WESLEYAN RISK AVERSE FUND (CLASS X) ACCUMULATION UNITS (ISIN GB00BYNYHP01)

This fund is a sub-fund of the Wesleyan Authorised Unit Trust.

This fund is managed by Wesleyan Unit Trust Managers Limited, which is wholly owned by Wesleyan Assurance Society.

OBJECTIVES AND INVESTMENT POLICY

Objectives


The fund aims to provide capital growth over a period of at least five years. We measure the success of the fund as outperforming a benchmark over a rolling five-year period. We do this by comparing the investment performance, after fees and charges, to a composite benchmark which reflects the current risk rating of the fund. The benchmark is a target for the fund.

The composite benchmark is composed as follows: 85% FTSE Actuaries UK Conventional Gilts up to 5 years Index, 5% FTSE Actuaries UK Conventional Gilts over 15 years Index, 7.5% FTSE Actuaries UK Index Linked Gilts All Stocks Index and 2.5% Sterling Overnight Index Average (SONIA) interest rate benchmark. The organisation decides which asset classes to invest in based on its investment policy and the specific objectives of each fund.

Investment policy

- ► The fund aims to achieve a return by investing in a portfolio largely made up of UK government bonds. These are generally considered to be a relatively safe investment compared with shares.
- When returns are very low, the fund will generally hold short-dated maturities which could provide more security for its investors than in potentially volatile long-dated government bonds.
- ▶ The fund holds up to a maximum of 5% cash.
- ➤ You can buy and sell units in this fund on any dealing day. (There is more information about when you can buy and sell units in Clause 3 of our Prospectus which you can ask us to send you.)
- ▶ All income is reinvested in the fund.
- ➤ The management team use their discretion to select assets in order to achieve the investment objective (active management).
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

RISK AND REWARD PROFILE



- ▶ The risk category is based on the rate the fund's value has moved up and down in the past. The fund's value can be influenced by changes in stock market prices, currencies and interest rates which can be affected by factors such as political and economic events.

- ▶ A fund in the lowest category does not mean a 'risk free' investment.

The following are the main risks of investing in this fund.

- ▶ Interest rate risk: the risk that interest rates could change and growth is lower than expected.



PAST PERFORMANCE



* The fund was launched on 3 June 2016. 2016 performance data is based on the part year from launch to end of 2016. From 3 June 2016 to 20 January 2019, the fund was a short term money market fund invested predominantly through sterling denominated short term deposits, money market instruments and government and public securities. From 21 January 2019, the fund is invested predominantly through UK government backed securities.

The past performance shown above is after charges, up to 31 December 2023, whereas the benchmark return is before charges. Therefore, if the performance before charges meets the benchmark, the performance after charges would be below the benchmark.

The table below shows the performance of the fund before charges compared to the fund's benchmark. The fund's benchmark changed on 1 May 2021 and performance before this date is based on the old benchmark. Further to this, the fund was not benchmarked prior to 2019.
