This fund is a sub-fund of the Wesleyan Authorised Unit Trust.

This fund is managed by Wesleyan Unit Trust Managers Limited, which is wholly owned by Wesleyan Assurance Society.

### **OBJECTIVES AND INVESTMENT POLICY**

#### **Objectives**


The fund aims to provide capital growth over a period of at least five years. We measure the success of the fund as outperforming a benchmark over a rolling five-year period. We do this by comparing the investment performance, after fees and charges, to a composite benchmark which reflects the current risk rating of the fund. The benchmark is a target for the fund.

The composite benchmark is composed as follows: 95% FTSE All-World Index and 5% Sterling Overnight Index Average (SONIA) interest rate benchmark. Invested capital is however at risk and there is no guarantee that the objective will be attained over this or any period.

### **Investment policy**

- ► The International Growth Fund invests in global companies. It can invest directly in most major countries across the world, giving it access to a wide variety of sectors and markets.
- ► The fund can also use third party investment vehicles (such as to access specific niche areas or emerging markets).
- ► The geographic exposure of the fund varies, depending on where the fund manager finds value, but unitholders can expect the USA to play a significant role, with Europe, UK, Asia and Emerging Markets also featuring in the fund mix.
- ► The fund invests with a long-term view and doesn't expect a high level of portfolio turnover. Cash levels will not exceed 10% of the fund value but could vary depending on underlying stock market conditions. It doesn't invest directly in tobacco companies.
- ➤ You can buy and sell units in this fund on any dealing day. (There is more information about when you can buy and sell units in Clause 3 of our Prospectus which you can ask us to send you.)
- ▶ All income is reinvested in the fund.
- ► The management team use their discretion to select assets in order to achieve the investment objective (active management).
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 5 years.

#### RISK AND REWARD PROFILE



- ➤ The risk category is based on the rate the fund's value has moved up and down in the past. The fund's value can be influenced by changes in stock market prices, currencies and interest rates which can be affected by factors such as political and economic events.

The following are the main risks of investing in this fund.

- ▶ Market price risk: the risk that the value of holdings will fluctuate because of changes in market prices caused by factors other than interest rates or currency movements.

- ▶ Interest rate risk: the risk that interest rates could change and growth is lower than expected.


